

## Power of Attorney

This Power of Attorney is entered into by and between

JIANGXI KOSIN FRONTIER TECHNOLOGY CO.,LTD. with its principal office at  
Yuan Shangang Industrial Park ,Dongxiang County,Jiangxi Province 331800,China (Hereinafter referred to as "CLIENT")

And REACH24H Consulting Group with its principal office at  
Paramount Court, Corrig Road, Sandyford, Dublin 18, Ireland (Hereinafter referred to as "REACH24H ")

To fulfill the Registration obligations of importers as required by "Registration, Evaluation, Authorisation and Restriction of Chemicals, Regulation (EC) No. 1907/2006" (hereinafter referred to as "REACH") for the chemical substance(s) listed in Annex, the CLIENT, as a non-EU manufacturer, hereby retains and appoints REACH24H as the "Only Representative" of REACH Registration according to Article 8 of REACH.

- This Power of Attorney shall become effective upon the date of signing. Termination is possible at any time according to related EU regulations, agreement between CLIENT and REACH24H or CLIENT's official request in written.
- This Power of Attorney remains valid from the date of signature to December 31, 2021.
- According to "Guidance on Registration (v3.0)" by ECHA:  
*"When appointing an only representative, it is recommended that the "non-EU manufacturer" provides his only representative with up to date information on the list of EU importers which should be covered by the registration of the only representative and the quantities imported into the EU."*  
*"In cases where an importer is also importing quantities of the same substance directly, then both the only representative and the importer must be able to clearly document to enforcement authorities which imports are covered by the registration of the only representative; and which are covered by the importer; otherwise, the importer remains responsible for all his imports."* -page 20, 21

Therefore, any EU importer of the CLIENT could be relieved from the Registration obligations of importer, and act as a downstream user of REACH24H under Registration obligation, only provided that:

- 1) Once receiving confirmation from the CLIENT on the appointment of the only representative, EU importer contact REACH24H at the first time to confirm whether covered in the downstream user list of REACH24H or not, as REACH24H will NOT cover the obligation for the importers outside the list; and,
- 2) EU importer communicates with REACH24H through the NEWRSCC IT system to request the "REACH Compliance Import Certificate" issued by REACH24H (which may be demanded by enforcement authorities, e.g. Customs House) to confirm that his imported tonnage is indeed covered by REACH24H, as REACH24H will NOT cover the obligation of importer for the volume outside the "REACH Compliance Import Certificate".

Otherwise, REACH24H will NOT cover the obligations of EU importers under REACH Registration, and the EU importer shall remain responsible for all his imports. This POA shall only be valid to the Registration obligations under REACH regulations.
