#### SECTION 5 FIREFIGHTING MEASURES

**Suitable extinguishing media:** Foam. Dry chemical powder. Carbon dioxide. Water spray or fog - Large fires only.

**Special hazards arising from the chemical:** Liquid and vapour are highly flammable. Severe fire hazard when exposed to heat, flame and/or oxidisers. Vapour may travel a considerable distance to source of ignition. Heating may cause expansion or decomposition leading to violent rupture of containers. On combustion, may emit toxic fumes of carbon monoxide (CO).

Special protective actions for fire-fighters: May be violently or explosively reactive. Wear breathing apparatus plus protective gloves in the event of a fire. Prevent, by any means available, spillage from entering drains or water course. Consider evacuation (or protect in place). Fight fire from a safe distance, with adequate cover. If safe, switch off electrical equipment until vapour fire hazard removed. Use water delivered as a fine spray to control the fire and cool adjacent area. Avoid spraying water onto liquid pools. Do not approach containers suspected to be hot. Cool fire exposed containers with water spray from a protected location. If safe to do so, remove containers from path of fire.

#### SECTION 6 ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures:** Remove all ignition sources. Clean up all spills immediately. Avoid breathing vapours and contact with skin and eyes. Control personal contact with the substance, by using protective equipment.

**Environmental precautions:** Stop leak if safe to do so.

Methods and materials for containment and cleaning up: Minor Spills: Contain and absorb small quantities with vermiculite or other absorbent material. Wipe up. Major Spills: Water spray or fog may be used to disperse / absorb vapour. Contain spill with sand, earth or vermiculite. Use only spark-free shovels and explosion proof equipment. Collect recoverable product into labelled containers for recycling. Absorb remaining product with sand, earth or vermiculite. Collect solid residues and seal in labelled drums for disposal. Wash area and prevent runoff into drains.

#### SECTION 7 HANDLING AND STORAGE

Precautions for safe handling: Avoid all personal contact, including inhalation. Wear protective clothing when risk of overexposure occurs. Use in a well-ventilated area. Prevent concentration in hollows and sumps. DO NOT enter confined spaces until atmosphere has been checked. Avoid smoking, naked lights or ignition sources. Avoid generation of static electricity. DO NOT use plastic buckets. Earth all lines and equipment. Use spark-free tools when handling. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers securely sealed when not in use. Avoid physical damage to containers.

Conditions for safe storage, including any incompatibilities: Store in original containers in approved flame-proof area. No smoking, naked lights, heat or ignition sources.
